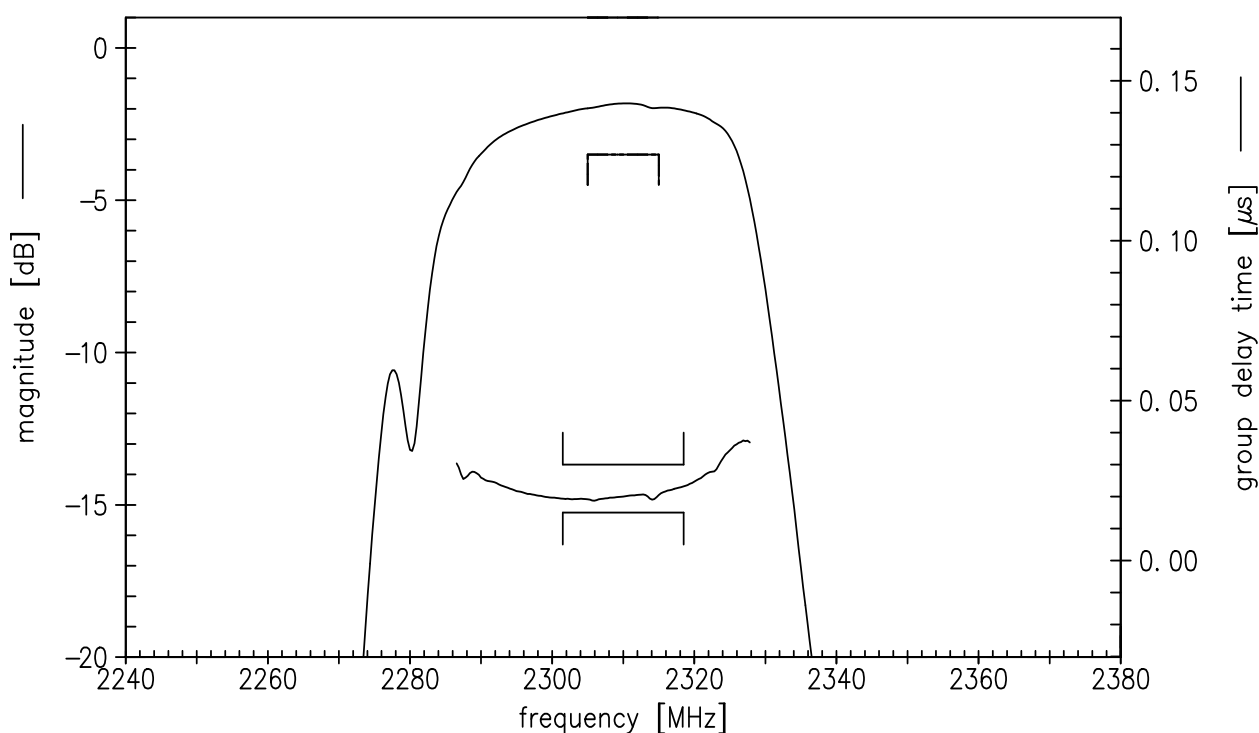

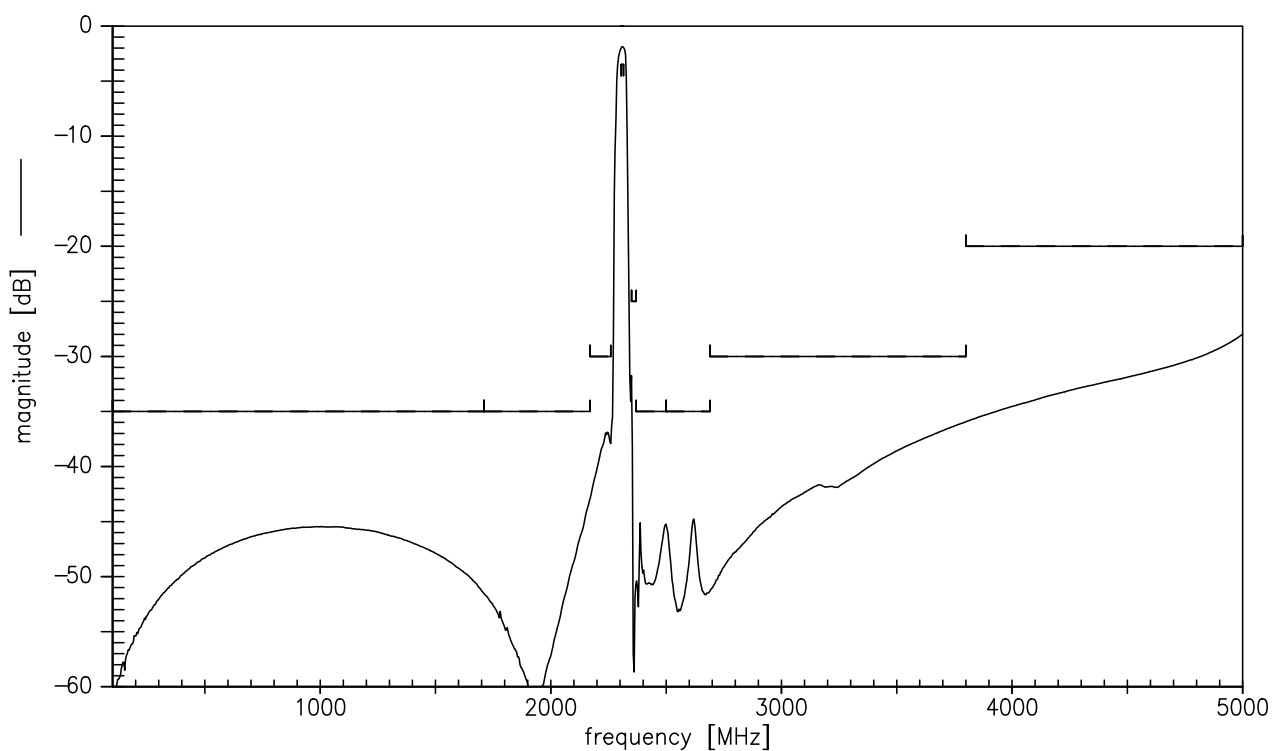

Transfer function (S21, narrowband)



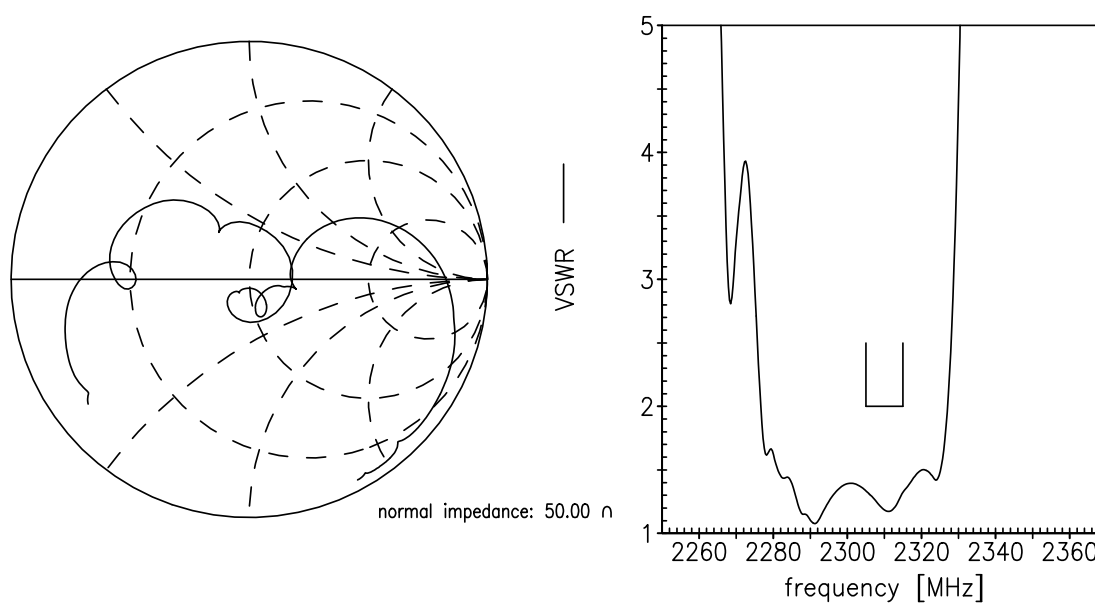
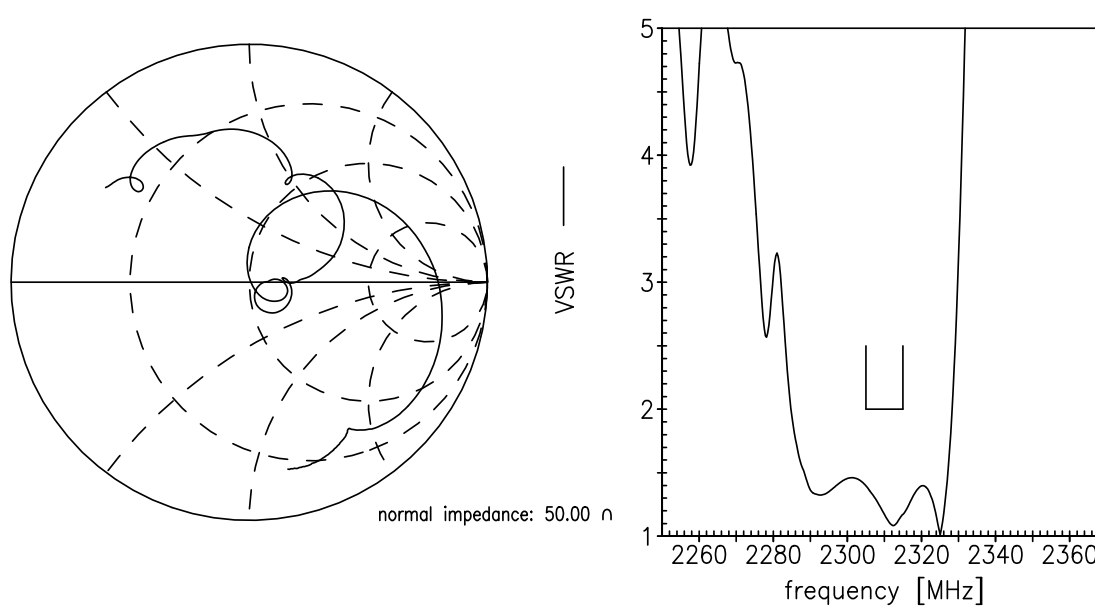
Transfer function (S21, wideband)
